4. PRIVACY POLICY PROVIDED PURSUANT TO ART. 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION 2016/679 (GDPR)

- 1. This information is provided pursuant to Art. 13 of Regulation (EU) 2016/679 on the protection of personal data (hereinafter "GDPR") refers to those who intend to fill in the request form (hereinafter "Form") to access the service rendered by the data controller through the SAOCOM system. A short way, please note that the GDPR protects the rights and freedoms of individuals with regard to the processing of personal data and provides rules on the free movement of such data. In this context, the Italian Space Agency ASI, as data controller, intends to inform data subjects about the use that is made of the personal data referred to them.
- 2. The personal data affected by this disclaimer are, in particular, those provided by the user by filling out the *form*, and include the name, surname, e-mail address, telephone number, date of birth, place of birth and home address.
- 3. The personal data you provide will be collected, processed and stored for the following purposes:
 - a. allow the management of user requests and provide the requested services and products.
 - **b.** sending by e-mail of advertising and promotional communications relating to the services and products of the owner.
- **4.** The legal base of the treatments under 3.a. is the performance of a contract of which the user is a party or the performance of pre-contractual measures taken at his request. The provision of data is optional, but necessary and, therefore, any refusal by the user to provide or to allow the personal data processing will make it impossible to access the services of the SAOCOM system.
- 5. The legal base of the treatment under 3.b. is the user's consent. If the consent in question is not given, personal data cannot be processed for this purpose and will be processed only for the purposes indicated above. The consent in question may be revoked at any time by sending a specific communication to the e-mail address rpd@asi.it or by writing to the owner's office or by clicking on the link relating to the revocation of consent present in the e-mails referred to in point 3.b.
- **6.** The user's personal data, subject to any litigation, will be kept, for the purposes under 3.a., for 15 years. For the purposes under 3.b. up to a maximum of 24 months, after which the data will be deleted, or made anonymous, and used for statistical purposes only.
- 7. All data will be processed by only authorized personnel (art. 2-quaterdecies of D.lgs 196/2003 as amended by D.lgs 101/2019), trained in the matter the protection of privacy, guaranteeing the application adequate security measures to protect the information.
- 8. The Personal data, except in fulfillment of any legal obligations, will not be disclosed or disseminated to third parties other than the Owner, the Managers, data processing operators or, in application of the current regulatory provisions, by Public Administrations and / or Public Authorities. In particular, the data may be communicated to external companies, appointed for this purpose as Managers, who perform functions connected and instrumental to the operation of the service, who are authorized to operate within the scope of the processing allowed to them, in relation to the activities carried out and following the owner's operating instructions.
- **9.** The owner of the personal data is l'Agenzia Spaziale Italiana ASI, in the person of its pro tempore legal representative, headquartered in Roma, Via del Politecnico s.n.c. (RPD), The Data Protection Officer (hereinafter referred to as the "DPO"), can be contacted at the following Email address:: rpd@asi.it.
- 10. The data subjects may exercise, on their data, all the rights set forth in the art. 15 to 22 of the GDPR including, in particular, that of asking the owner of the personal data, for access to personal data and for rectification, cancellation of the same or the limitation of the processing concerning him or to oppose their treatment, in addition to the right to data portability in the cases provided for by the rules. These rights may be exercised by writing to the Owner at its headquarters, at the address mentioned above, or by writing to the email address: rpd@asi.it. In the event of violation of the relevant legislation on the protection of confidentiality and personal data, the interested party can always lodge a complaint with the Guarantor Authority for the protection of personal data whose contact details can be found on the website www.garanteprivacy.it.
