### 1. SCOPE AND PURPOSE

### 1.1 SCOPE

This guide has the objective to give all the information needed for users in order to request membership, submitting orders and obtaining the data acquired by the CONAE SAOCOM 1 satellite constellation, over the geographical zone in which ASI has an exclusive right to use and hence to disseminate the data.

### 1.2 PURPOSE

Access to SAOCOM mission data acquired over the ASI' Zone of Exclusivity (ZoE) requires that the user requests membership to this service:

- a) having read and accepted the ASI-CONAE SAOCOM License to Usage Agreement and
- b) having compiled the related documentation (Liability declarations, Membership registration form) At the current stage, the membership will be requested by the user through an email sent to a specific mailbox, as explained in the next sections.





### 2. APPLICABLE AND REFERENCE DOCUMENTS

### 2.1 APPLICABLE DOCUMENTS

The request of membership to the access service to the SAOCOM product presented here is based on the following documents at their latest revision and date of issue.

- [AD2] SAOCOM Licence to USE, signed between CONAE and ASI on 28 feb 2020

### 3.2 **DEFINITIONS**

Affiliated User	Natural or legal person who shares the use of the ORIGINAL SAOCOM PRODUCT or the PROTECTED PRODUCT with the End User within a Joint Project, based on the clauses and conditions established in this License, which must be accepted accordingly.
Ancillary Data	Subset of technical data related to the SAOCOM system that are added to the SAOCOM Product.
Derived product	It is the Product generated by the user from an ORIGINAL SAOCOM PRODUCT or from a PROTECTED PRODUCT, after applying different processing and/or addition methods and techniques, which produce significant and irreversible modifications to the ORIGINAL or the PROTECTED PRODUCT so that the initial characteristics of the SAOCOM PRODUCT are no longer identifiable either in whole or in part
Final User	One of the Main User, Affiliated or Contractor/Consultant who use the SAOCOM products for the needs to execute a Joint Project
Joint Project	Specific project which entails the joint use of the SAOCOM PRODUCT by the End User and one or more Affiliated Users, under the clauses of this License in the framework of the SIASGE MOU.
Original product	Indistinctly means any Product generated from Raw Data from the SAOCOM satellites, generated by CONAE with its metadata. They can be classified as Level 1 (Standard Product 1 A, 1 B, 1 C, 1 D), Level 2 or Higher-Level. Level 2 or Higher-Level products shall be considered Original SAOCOM Products, regardless of whether it still contains identifiable initial characteristics of the Level 0 or 1 products used by CONAE to process and generate them. In this sense, the Products under this category (Level 2 or Higher Level) such as the "Soil Moisture Map", the "Ships Map", the "Fusariosis Forecast Map" generated by CONAE, or those that it may be defined by CONAE in the future, shall be considered as "Original SAOCOM Product".
Protected product	It is a product generated by the user from an ORIGINAL SAOCOM PRODUCT, where the initial characteristics of the ORIGINAL PRODUCT are still identifiable either in whole or in part after applying to them different methods and processing or merging techniques. Copies of the PROTECTED PRODUCT and/or parts thereof on any media are also PROTECTED PRODUCTS
Purposes of Use	It refers to the Use of the SAOCOM Products by the End User for the activities under the terms of the MOU. This does not include any right to sell, assign, lease, distribute or transfer the ORIGINAL SAOCOM PRODUCTS or the PROTECTED PRODUCTS, or any part thereof, or to use them in any manner not expressly authorized by this License or in writing ad hoc by CONAE.
Use	The term "Use" includes but it is not limited to: installation, visualization, copying, processing, printing, via web transmitting/receiving, the storage of ORIGINAL or PROTECTED SAOCOM PRODUCTS on the User's computers or other devices for the purposes of Internal Use for which they are acquired. This License does not include commercial, online or web uses.







User	In the SAOCOM Licence to Use, the User is the Italian Space Agency (ASI Agenzia Spaziale Italiana) who has the right to use the Products for the Purposes of the MOU but also the right to have Affiliated Users with whom share the SAOCOM products.
	In the registration form, the User is one of the Main User, Affiliated or Contractor/Consultant. In relation to the SAOCOM License to Use Agreement, such users (i.e. the final users) are formally "Affiliated users" of ASI.

### 4. SAOCOM, SIASGE AND THE ASIZONE OF EXCLUSIVITY

ASI and CONAE decided to collaborate for the development of the SIASGE project (COOPERATION ON THE ITALO-ARGENTINE SATELLITE SYSTEM FOR EMERGENCY MANAGEMENT, ECONOMIC DEVELOPMENT AND SOCIAL ADVANTAGE) as defined in the MoU [AD-01]. In such collaboration, a certain amount of SAOCOM data acquisition and processing resources has been reserved to ASI for exclusive use in the so-called Zone of Exclusivity (ZoE) shown in next figure in YELLOW, placed in the 10W-50E longitude range and 30-80N latitude range. Such ZoE has a southern latitude limit, in the longitude range from Gibraltar to Suez channel, constituted by the territorial waters of the North African Countries (12nm form the coastline) and hence not by a constant latitude arc. On such area, ASI has the right to use the SAOCOM system freely, fully and up to the saturation of the granted resources (around 150s of sensing time per orbit).




Figure 1 – ASI Zone of Exclusivity

The MoU [AD-01] underlines the importance of the SIASGE system as mainly dedicated to Risk Management and Agriculture, with the following priority applications: Priority 1:

- Floods
- Landslides
- Seismic and volcano
- Oil spill
- Earthquake
- Natural or anthropic disaster

### Priority 2:

- Soil moisture for agriculture production
- Soil and vegetation moisture for crop disease
- Soil moisture for Floods

### Priority 3:

- Other applications considering emergencies not included in the previous Applications

### **5.** ACCESS TO SAOCOM DATA OVER ASIZOE

### 5.1 USER MEMBERSHIP REQUEST AND REGISTRATION PROCEDURE

The delivery of the PRODUCTS is subject to the User Membership Request and Registration activity. The registration procedure requires the User (technically the Main User, see below):

- to define the composition of the group who will have access to the SAOCOM data
  - o group shall mandatory include a single Main User
  - o group could include zero or more final users which are Affliated Users of the Main User
  - o group could include zero or more final users which are Contractors/Consultants of the Main User
  - o group size shall not exceed 50 members
- to fill the Membership registration form with information about
  - the group members (e.g. Name, Surname, email, etc)
  - o the data exploitation project (e.g. duration, description, area of interest etc)
  - o the foreseen use of the data, chosen from one up to five categories
- to self assign himself/herself to one of the allowed User categories (e.g. ASI User, National Science, International institutional, etc)
- to compile -for each organization involved in the final users group- the SAOCOM Release of Liability Declaration containing
  - o list of the final users belonging to that organization
  - o full identification (e.g. Name, Address, Country etc) of the Organization
  - o full identification (e.g. Name, Surname and Function) of the Legal Representative of such organization
  - o place and date of signature
  - o the electronic qualified signature of Declarant's Legal Representative
- to explicitly declare (inside the membership request email): to have read, understood and fully accepted the ASI-CONAE SAOCOM License to Use Agreement
- to explicitly declare (inside the membership request email) to take all the penal and administrative consequences deriving from the falsification in documents and from incomplete and / or mendacious declarations relating to the information entered in the membership request
- to submit the membership request

In the case of approval of the Request of Mebership by ASI, the user will receive the access credentials. Following the registration procedures, a specific account will be assigned to the User group. All personal data provided by the User group shall be electronically stored by ASI and by the ASI contractors that implement the operational activities of the SAOCOM system, in the name and on behalf of ASI (including the user support).

# 5.1.1 ELECTRONIC QUALIFIED SIGNATURE OF SAOCOM RELEASE OF LIABILITY DECLARATIONS

The signature of the release of Liability declarations, one declaration per each organization involved in the final users group, shall be executed electronically by the legal representative of the organization by mean of a Qualified Electronic Signature (QES). No other signature methods/types will be accepted. The presence of one/many incomplete, inconsistent or unsigned declarations will cause the rejection of the membership request.

### 5.3 ACCESS TO DATA ARCHIVED ON ASI DISSEMINATION SYSTEM

Data archived and catalogued in the ASI dissemination system, based on a customized version of the DHuS, can be accessed by log-in on <a href="http://saocom.asi.it:8081">http://saocom.asi.it:8081</a> with the credential received after a successful membership request. The SAOCOM Data Hub is based on a version of the DHuS system (originally developed by ESA for EC Copernicus constellation) customized for the SAOCOM mission specificities. ### 5.4 ACCESS TO DATA ARCHIVED ON CONAE DISSEMINATION SYSTEM

Data acquired on the ASI ZoE, which at the date is still archived and catalogued only in the CONAE dissemination system, can be requested to be transferred in the ASI dissemination system, searching the PRODUCT IDs of interest (a long string like EOL1CSARSAO1A1867930 or EOL1ASARSAO1A1867932 or EOL1CSARSAO1A1867959 etc) in either the following ways:

- 1. in an excel file, regularly updated and disseminated by ASI
- 2. in a kml file, regularly updated and disseminated by ASI
- 3. using the CONAE dissemination system <a href="https://catalog.saocom.conae.gov.ar/catalog/">https://catalog.saocom.conae.gov.ar/catalog/</a>







### 5.4.1 RETRIEVING THE PRODUCT ID BY THE EXCEL FILE

ASI provides (and update periodically) an excel file containing the main metadata of all the products generated in the ZoE. Among the various fields, such file contains the following info:

- Product ID: is the long string (e.g. EOL1BSARSAO1A645992) identifying a product processed at some (non zero) level
- Parents ID: is a long string i(e.g. EOL0ASARSAO1A640607) dentifying the source Level 0 product which
  originated the product processed at some (non zero) level
- Processing level: the processing level of the product, choisen between L1A (single look complex, slat range), L1B (detected, ground range), L1C (geocoded on ellipsoid), L1D (geocoded on DEM)
- Platform; SAO1A (in future SAO1B too)
- Production Start / End time: the generation date of the product
- Sensor mode: STRIPMAP for data acquired at fixed azimuth steering or TOPSAR for data acquired in ScanSAR like mode
- Sensor submode: indication of the beam for STRIPMAP (S1 up to S10) or TOPSAR mode A or B or TOPSAR WIDE
- Polarization: Double polarization HHHV or VHVV, Quad Polarization, Single polarization HH or VV
- Looking mode: RIGHT or LEFT
- Orbit type: ASCENDING or DESCENDING
- Acquisition Start / End time: time of the acquisition
- GeoJSON: a JSON formatted string containing a closed (5 vertices) polygon representing the product contour in latitude/longitude coordinates




Figure 5 –ZoE contents, columns Y-AA

### 5.4.2 RETRIEVING THE PRODUCT ID BY THE KMZ FILE

ASI provides (and update periodically) a kml file containing for each product, the Product ID and the contour. The file can be easily loaded in Google Earth.










Figure 6 –ZoE contents, kml loaded in Google Earth

### 5.4.3 RETRIEVING THE PRODUCT ID BY THE CONAE CATALOGUE SITE

The CONAE dissemination system <a href="https://catalog.saocom.conae.gov.ar/catalog/">https://catalog.saocom.conae.gov.ar/catalog/</a> allows to be searched with geo-spatial queries even without any registration.










Figure 7 - CONAE dissemination system




Figure 8 – CONAE dissemination system catalogue query

You can hence retrieve and annotate the IDs of the product/s of your interest, create a list (plain text, one product per row) and send it to the ASI SAOCOM Orders email which is <a href="mailto:SAOCOM\_ORDERS@asi.it">SAOCOM\_ORDERS@asi.it</a> with mandatory subject "Existing SAOCOM Product Order".

The products will then be ordered by ASI to CONAE and made available on the ASI DISSEMINATION SYSTEM <a href="http://saocom.asi.it:8081">http://saocom.asi.it:8081</a> after a latency related to the order's processing-time by CONAE and the product transfer-time from CONAE SAOCOM Archive.

### 5.5 ORDERING AND ACCESS TO NEW ACQUISITIONS

This capability is not actually implemented and will be available soon.







### 6. HOW TO COMPILE THE MEMBERSHIP REQUEST

The following paragraph describes the Membership Registration form which shall be compiled by the Main User, filling up all the requested fields in the two sections of User Info and Project Info.

The **User Info** section contains identity information of all the members of the user group, whose size ranges from #1 (i.e. the Main User alone) to #50, and includes users who are affiliated to the Main User and users who are Contractor or Consultant of the Main User. All fields, for any filled rows of the table, are mandatory, filling of the first row it's also mandatory.

Note that the SAOCOM License to Usage Agreement allows the freely dissemination and usage of the DERIVED products, with minimal obligations for the User who generated them. Hence, people which intend to exploit only the DERIVED products and NOT the ORIGINAL or PROTECTED products, does not need to register themselves as SAOCOM users.




Figure 9 – Registration form: user info

The required fields for this section are:

- TYPE: can be MAIN for the Main User (mandatorily in the first row), AFFILIATED or CONTRACTOR/CONSULTANT for optional users
- Name, Surname: of the user
- Company or Institution: the name of the organization in which the user works; fill with "None" for users without any affiliation (e.g. private citizens)
- Address, City, Zip code, State or Province, Country, Telephone: data referring to the organization to which
  the user belongs to, or to the user for private citizens; phone number shall include the international prefix
  in the form +NN and NOT 00NN (e.g. +39 and not 0039, in the case of Italy)
- e-mail: shall be a valid email
- Privacy Advertisement: use this flag to signal if you allow ASI to send you information about SAOCOM
  mission like: news, workshop notices, etc. All the information entered in the Membership Request are
  managed by ASI according to the [AD4] SAOCOM PRIVACY POLICY document, contained in the
  SAOCOM Data Package

The **Project Info** section contains the project data and Main User (self classification) category assignment.

The required fields for this section are:

- Title: mandatory, is the project title
- Duration: mandatory, duration of the project in number of months digits not letters
- Description: mandatory and containing >150 words; a word counter on the right, help to keep track of the minimum length of the description; a project description with less than 150 words cannot be accepted
- Area of Interest 1<sup>st</sup>: mandatory, no specific format required
- Area of Interest 2<sup>nd</sup>: optional, no specific format required
- Area of Interest 3<sup>rd</sup>: optional, no specific format required
- Use of Data 1<sup>st</sup>: mandatory, choose between allowed categories the one better resembling the foreseen use of data
- Use of Data 2<sup>nd</sup>: optional
- Use of Data 3<sup>rd</sup>: optional
- Use of Data 4<sup>th</sup>: optional
- Use of Data 5<sup>th</sup>: optional
- User Category: mandatory, choose between allowed categories the one better resembling your category, see below

The next table lists the categories of Users along with some example and notes. Please try to select in the Project Form the category that best resembles the one you belong to and <u>use "Generic" only if you cannot adequately fit in the other categories</u>. **Generic user shall always have the lowest possible privileges**. Please don't use the "Special user" category unless agreed with ASI.

### 7. IMPORTANT – HOW TO SEND THE MEMBERSHIP REQUEST

Once the User Info and Project Info sections have been completed (please double check all fields are correctly compiled, that they are consistent, etc), put the Membership Registration form as an attachment to an email, together with the various Liability declarations. No particular name coding is required but please use meaningful names.

The email destination address shall be: SAOCOM\_UserMng@asi.it

The email subject shall mandatory be: SAOCOM Membership Request

The email body shall mandatory include the declaration below:

The Main User takes all the penal and administrative consequences deriving from the falsification in documents and from incomplete and / or mendacious declarations relating to the information entered in the Membership request. The Main User also declares to have read, to have understood and to accept all the terms and articles contained in the ASI-CONAE SAOCOM License to Use Agreement.

**The number of liability declarations** shall mandatory match the number of distinct organizations as reported in the Membership Registration form.







### 8. IMPORTANT - SUMMARY OF DO AND DON'T WITH SAOCOM IMAGES

The SAOCOM products are made available by CONAE to ASI under a formal License (SAOCOM Licence to Use Agreement). ASI then disseminate such products to the final users by formally making them affiliated to ASI itself. Hence the rules CONAE does apply to ASI are fully inherited by the final users.

Below is reported a non-exaustive summary of the main rules and obrigations related to the SAOCOM License (in square brackets the cross reference with the articles of the SAOCOM Licence to Use Agreement):

- During the registration phase users shall have identified themselves and shall have accepted the clauses
  of the SAOCOM License [see III.Permitted Uses.1]
- License does not allow commercial, online or web uses [Definitions]
- Users shall have the right to publish an extract of the SAOCOM Products, to the extent and under the terms stipulated in Article IX of the SAOCOM Licence [see III.Permitted Uses.4]
- Any use of the SAOCOM Original or Protected products other than for those users authorized by the SAOCOM License is prohibited. The transfer in whole or in part of the SAOCOM License, or of any of the rights related to the SAOCOM License or similar assignments to third parties, is explicitly prohibited unless with the prior written consent of CONAE and ASI [IV.Prohibited Uses.1]
- The User shall not reproduce, transfer, trade, sell, rent, lease, distribute or make available to third parties
  in any way, whether for a fee or free of charge, the Original or Protected SAOCOM products or the
  supplementary and/or ancillary information or data provided by CONAE together with a SAOCOM
  products, unless explicitly authorized by CONAE and ASI in writing on an ad hoc basis [IV.Prohibited
  Uses.2]
- None of the Original or Protected SAOCOM products under the SAOCOM License may be used for commercial purposes [IV.Prohibited Uses.2]
- No modification or removal of the copyright notice, the brands or any other feature that accredits CONAE's rights in the Original or Protected SAOCOM products is permitted [IV.Prohibited Uses.3]
- Any conduct that is not in compliance with the clauses of the SAOCOM License or that does not comply
  with it, may cause the termination of the License granted and will generate a direct responsibility of the
  final user (via the Liability declarations) with the compensation of the damage to CONAE's rights [see
  IV.Prohibited Uses.4]
- The final user shall add the following note to a Protected product: "SAOCOM® Product ©CONAE (year of acquisition). All rights reserved" Product processed under CONAE license in the framework of the SIASGE Cooperation Agreement CONAE-ASI" [V.Protected Products.2]
- The final user commits to notify CONAE and ASI in case of development of a new intellectual property right in the course of the processing of a Protected Product [V.Protected Products.4]
- The final user is entitled to attach its own copyright notice on the Protected product and shall also attach the following notice on the Protected Product: "Product produced from Original SAOCOM® Product ©CONAE (year of acquisition)" [V.Protected Products.5]
- The final user may freely dispose of the Derived product but must mention the SAOCOM Product as the source by meand of the following notice "Product produced from Original SAOCOM Product - ©CONAE – COMISION NACIONAL DE ACTIVIDADES ESPACIALES (year of acquisition)" [VI. Derived Products.2]
- The final user may not distribute, duplicate or transfer to the Derived products the Ancillary Data provided by CONAE together with a SAOCOM Product [VI. Derived Products.3]
- The final user guarantees the respect for CONAE's intellectual property rights over the Original and Protected SAOCOM products and undertakes to notify CONAE and ASI in writing of any illegal use, including that of third parties, of the Original SAOCOM products supplied or the Protected products processed under the terms of the SAOCOM License [VII.Intellectual Property.5]
- Any infringement and/or violation of CONAE's intellectual property rights will cause the extinction of the
  right to use the SAOCOM Products and will entail the direct responsibility of the final user (via the Liability
  declarations), including the reparation of damages caused to CONAE [VII.Intellectual Property.6]
- Final user shall have the right to use SAOCOM Products only for the purpose of the performance of the Project. Once the same is finished, the final users will not have the right to continue with the Use of the SAOCOM Products, nor to keep it, nor to keep copies of it, unless otherwise agreed with CONAE and ASI [VIII.Use of SAOCOM Products with Affiliated Users. Joint Project.2]
- CONAE shall have the right to terminate this License immediately in the event of breach of any of the
  clauses by the final user, as specified therein, and to request the immediate return of the SAOCOM
  Products. Any conduct not in conformity with or in violation of the instructions and directives under the
  SAOCOM License to use or of further and/or different ones given by CONAE shall cause a direct liability







- of the final user (via the Liability declarations) also for the compensation of the damage in case caused to CONAE's rights [VIII.Use of SAOCOM Products with Affiliated Users. Joint Project.3]
- The final user may publish an extract of the Original SAOCOM product or the Protected product in printed form or on its website, only as part of academic works or for promotional purposes. In both cases, <a href="Months:CONAE">CONAE</a> prior consent must be requested by sending an e-mail to: aviso.got@conae.gov.ar including the reference of the work. To this end, the image (Product) may be published in JPEG or printed format, with a maximum size of 1024x1024 pixels and with the obligation to mention CONAE's copyright over the SAOCOM Product in the publication [IX.Reports, Publications and Participation in conferences.1]
- CONAE shall always have the right to deny or restrict access to SAOCOM Products when it deems it
  necessary, or when the availability of the products or their distribution is limited due to reasons of national
  security, emergencies, satellite maintenance and health, or force majeure [X.Warranties and Limitations
  of Liability. Restrictions.1]
- The final user (via the Liability declarations) shall be liable for the use they give to SAOCOM Products supplied by CONAE [X.Warranties and Limitations of Liability. Restrictions.2]
- The SAOCOM Product is delivered "as is", therefore, CONAE does not assume nor will be responsible for the accuracy or suitability of the SAOCOM Products that the User has had or may have in view with the use thereof, or with any present or future expectation that the User may have with respect to the acquisition, application and/or functionality of the SAOCOM Product, and this may not give rise to a claim of any kind [X.Warranties and Limitations of Liability. Restrictions.4]
- Likewise, since the SAOCOM Products are complex and processed products, CONAE does not guarantee
  that the Product is free from any defect, bug, error or omission. Therefore, the final user shall not have the
  right to file any lawsuit or claim against CONAE (or ASI via the Liability declarations) for any direct or
  indirect loss and/or damage connected to the use of the SAOCOM Products [X.Warranties and Limitations
  of Liability. Restrictions.5]
- In no event shall CONAE (or ASI via the Liability declarations) be liable for any direct or indirect damages, or for losses, whether foreseeable or unforeseeable, of any kind connected to the use of the product [X.Warranties and Limitations of Liability. Restrictions.6]
- CONAE hereby has the right to terminate this License immediately in case of breach of any of the clauses and conditions contained herein by the final user [XII.Right of Termination.1]
- In the event that CONAE terminates this License in accordance with the foregoing paragraph, the User shall have no right to any claim; in such case, the final user shall return the SAOCOM Product(s) and any copies thereof, and shall no longer have any right of use over it [XII.Right of Termination.2]
- The License shall come into force on the date of ASI approval of the registration of the final user and shall remain in force until it is superseded by a license renewal or terminated by CONAE pursuant to the foregoing Section XII above [XIII.Entry into Force. Duration.1]

### In addition to the previous rules:

- the access to the SAOCOM product dissemination system and therefore the possibility of requesting products generated by new acquisitions and/or archived acquisitions, is subject to the approval of the ASI, as specified below, and control/monitoring by the competent Institutional Authorities on the matter; in particular, in order to guarantee national security, territorial integrity, the protection of national and foreign policy interests, these Authorities may impose limitations both on the distribution of the Products on specific areas of the globe and on the registration and/or the operations of some Users. ASI is required to provide to these Authorities all technical and operational support necessary for the execution of the aforementioned activities
- the approval by ASI of a request for registration by an user and therefore to the access to the system takes
  place after the following actions by the user himself: supply of his/her personal data, compilation of the
  project form, supply of liability declarations signed with a valid qualified electron signature and explicit
  acceptance of the terms and conditions of the SAOCOM license to Use Agreement
- the obtaining of products generated by new and/or archived acquisitions is guaranteed to users, regardless
  of the nationality and type of organization to which they belong, but it is subject to the checks previously
  indicated
- each final user can only use a part of the CONAE SAOCOM system and of the ASI dissemination resources, coded in terms of user quotas
- each user is assigned a specific priority in order to allow the system to resolve any conflicts may arise during the acquisitions planning phase
- each user will have a specific privilege for request new acquisitions or products generated from archived acquisitions or both
- the SAOCOM products are supplied to all users at no cost (free of charge)







- the user is required to provide ASI, on a yearly basis, with a summary report on the actual use of the products and on the results obtained from the exploitation activities
- the user acceptance (during the registration phase) of the SAOCOM license to Use Agreement, with the related terms and conditions for data usage, is mandatory
- the release of Liability declarations, signed with a valid qualified electronic signature, is mandatory
