Privacy statement pursuant to article 13 of Regulation 2016/679/UE (GDPR)

This Information is addressed to those who intend to fill in the form to register for the Event **“Innovating with EU Space: the EUSPA Opportunities for Italian Industrial and Research Communities”** organized by the Italian Space Agency and to be held on February 1th 2023 in Cassini Room.

The personal data on which the processing will be carried out are, in particular, those provided by the interested party by filling in the form and are processed for the sole purpose of processing the request to participate in the event and its management. The legal basis of the processing must be identified in the need to follow up on the request to participate in the Event (Article 6, paragraph 1, letter b), of the GDPR) and, simultaneously, in the pursuit of tasks of public interest of which is invested the Data Controller (Article 6, paragraph 1, letter c), of the GDPR), with particular regard to the institutional tasks of scientific dissemination in the aerospace field. The data may also be processed to fulfill legal obligations to which the Data Controller is subject (Article 6, paragraph 1, letter f), of the GDPR) and due to the legitimate interest of the Data Controller himself (Article 6, paragraph 1, letter f), of the GDPR), represented by reasons of security of its headquarters, as well as the need to ensure the normal running of the Event. The provision of the data requested in the Form is mandatory and any refusal to supply them will make it impossible to participate in the Event. The data collected will be kept for a period of time not exceeding the achievement of the purposes for which they are processed. All data will be processed, through automated systems as well as with paper supports, exclusively by authorized personnel (art. 2-quaterdecies of Legislative Decree 196/2003 as amended by Legislative Decree 101/2018) and specially trained in the matter of protection of confidentiality, ensuring the application of adequate security measures for the protection of the information itself. In relation to the purposes indicated, apart from the specific regulatory provisions, the data may not be disclosed or communicated to subjects other than the Data Controller or, in application of regulatory provisions, by Public Authorities. Personal data may also be communicated to third parties, appointed for this purpose as Managers, who perform functions connected and instrumental to the activity for which they are collected (such as the management and maintenance of the IT system or guardianship activities), who are authorized to operate within the scope of treatment permitted to them, in relation to the activities carried out and following the operating instructions given by the Data Controller. The Data Controller is the Italian Space Agency with registered office in Rome, Via del Politecnico s.n.c. The Data Protection Manager, domiciled for the purpose at the same offices, can always be reached by writing to rpd@asi.it. Each interested party has the rights referred to in articles 15 et seq. of the GDPR including, in particular, that of asking the Data Controller for access to personal data and the rectification, cancellation of the same or the limitation of the treatment that concern him or to oppose their treatment, in addition to the right to portability of the data in the cases foreseen by the regulations. These rights may be exercised by contacting the Data Controller or the Data Protection Manager of the Agency at the addresses indicated above. Interested parties who believe that the processing of their personal data, carried out by ASI, takes place in violation of the provisions of the GDPR have the right to lodge a complaint with the Guarantor, as provided for by art. 77 of the GDPR itself, or to take the appropriate judicial offices (art. 79 GDPR).
