

INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to Arts. 13 and 14 of Regulation (EU) 2016/679 (GDPR)

In compliance with Regulation (EU) 2016/679 (hereinafter “Regulation” or “GDPR”), this information notice describes the modalities of handling the personal data of the Data Subjects who intend to register to participate in the event titled “*CISE-ALERT VIP DAYS*” that is scheduled to be held at the Italian Space Agency (Agenzia Spaziale Italiana -ASI) for 11 and 12 September 2024 (hereinafter also simply “Event”), organized by ASI in association with the following partners: Secrétariat général de la mer (SGMer), Service Hydrographique et Océanographique de la Marine (SHOM), Direction Nationale Garde-Côtes des Douanes (DNGCD), Executive Agency Maritime Administration (EAMA), Agenzia delle Dogane e dei Monopoli (ADM), Ministry of National Defence, Greece (HMOD), Ministère de la Transition Écologique (MTE), Ministrstvo za Infrastrukturo (MzI), Direção-Geral de Política do Mar (DGPM), Ministério da Defesa Nacional (Defesa).

THE DATA CONTROLLER AND THE DATA PROTECTION OFFICER

The Data Controller is the AGENZIA SPAZIALE ITALIANA – ASI, with registered offices in Rome, on Via del Politecnico S/N, PEC asi@asi.postacert.it. The Data Protection Officer (DPO) can be reached at the e-mail address: rpd@asi.it.

TYPES OF DATA PROCESSED AND THE PURPOSE OF PROCESSING

ASI shall process the name and surname, e-mail address, date / place of birth and ID document of the Data Subjects for the purpose of enabling them to register to participate in the Event and manage the registration. It is mandatory to provide the data requested on the form and a possible denial to provide them shall entail the impossibility to participate in the Event. The data collected shall be stored for the time needed to organize the Event and shall be destroyed or anonymized and aggregated thereafter.

The personal data provided to subscribe to the aforesaid mailing list shall be stored for a period of 5 years, after which they shall be erased or stored in an anonymized and aggregated form solely for statistical purposes; denial of consent relative thereto shall not impede participating in the Event.

The data provided shall be used with manual, computer or telecommunication tools by people authorized to process them and shall be stored in compliance with the legal terms and obligations.

LEGAL BASIS FOR PROCESSING

The legal basis for processing arises from the need to process the application for participation in the Event. The personal data may also be processed to fulfil purposes of public interest and the legal obligations of the Data Controller (Art. 6, Para. 1 of GDPR).

In particular, the personal data processed by ASI are used to perform tasks of public interest or in any case connected to the exercise of its public powers linked to its institutional task of promoting “*the dissemination of the aerospace culture and of the knowledge deriving from research thereon*” (Art. 3, Para. 1, Lett. e) of

Legislative Decree N. 128 of 4 June 2003, as amended and supplemented, concerning the “*Reorganization of the Italian Space Agency*”) and of performing “*communication and promotion of space and aerospace research*” (Art. 2, Para. 2, Lett. k) of the “*Statute of the Agenzia Spaziale Italiana*”).

Instead, as regards the subscription to the mailing list, the legal basis consists of the free and explicit consent of the Data Subject.

RECIPIENTS OF THE DATA

The personal data collected are processed by ASI personnel who shall follow the specific instructions on the purpose and modality of processing under the responsibility of the Data Controller. The processing of the personal data collected may also be carried out by subjects other than the Data Controller, as long as they are instrumental to the performance of the event, such as the partners in the Project and natural or legal persons who, on behalf or/and in the interest of ASI and its partners, may perform activities that are connected and instrumental to, or supportive of the performance of the Event, for this task specifically appointed Processors as laid down in Art. 28 of Regulation (EU) 679/2016.

TRANSFER OF PERSONAL DATA

The data processed shall not be transferred to Third Countries or to international organizations.

RIGHTS OF THE DATA SUBJECTS

In the cases set forth, the Data Subjects have the right to obtain from ASI access to their personal data and the rectification or erasure thereof, or the limitation of the processing that concerns them or to object to the processing (Arts. 15 and ff. of the Regulation). The request can be submitted by contacting the Data Controller or the Data Protection Officer at the above-mentioned addresses.

RIGHT TO LODGE A COMPLAINT

The Data Subjects who believe that the processing of their personal data infringes the provisions made in the Regulation are entitled to lodge a complaint with the Supervisory Authority, as laid down in Art. 77 of the Regulation, or to seek judicial remedy (Art. 79 of the Regulation).
